Identification of Tree(s) and Description of Works

The sycamore tree is shown at (2) on the plan. We wish to remove the branches that overhang 7 Papillons Walk, in particular the large low overhang which has a detrimental impact on the garden. This self set tree is in a passage that runs to the rear of 24-28 Corner Green. It has not been pruned for very many years and is not being properly managed by its owner (Corner Green). We have written again to Corner Green to request that they manage their trees adjacent to our property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
