Liquidamber - I need to get this tree trimmed and made smaller as once again it is getting to big and close to the house.

I was advised last time this tree was pruned some if the branches in the middle of the tree are rubbing together so this will need thinning too.

We have had to had drains cleared due to roots from this tree so I am concerned to to the size it is becoming.

Please could I arrange a meeting with someone to talk through this TPO as I have a number of questions it would be great to get answered.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
