Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1: Lime, Tag 150 in inspection record: Hollowing of the trunk from base to first union at 15ft and potentially above. Further hollowing below previous pollard points, large amounts of healthy growth above creating a large sail area. To retain the tree and prevent failure we are seeking to re-pollard above these points working in sound timber reducing the overall height of the tree by 5m and radial spread by 2m in order to reduce wind loading on the tree.

T2: Lime, Tag 149 in inspection record: Hollowing of the trunk from base to below bolting. The tree has put on lots of healthy growth above this point and above a secondary crown with large sail area. To reduce wind loading on the tree from the growth above bolting, seeking to reduce the tree upper crown 9m in height and retain the lower secondary crown in order to preserve the tree and prevent failure.

T3: Horse Chestnut, Tag 0084 in inspection record: Young tree 9m height exhibiting bleeding canker and honeyfungus. Tree has excessive damage to the bark from base up to first union, branches from first union up have flaking bark and dead wood. Felling of this tree is sought as it will not produce a good specimen due to the diseases exhibited and current health of the tree.

T4: Horse Chestnut, Tag 0089 in inspection record: Young tree 8m height exhibiting bleeding canker and honeyfungus. Tree has excessive damage to the bark from base up to first union, branches from first union up have flaking bark and dead wood. Felling of this tree is sought as it will not produce a good specimen due to the diseases exhibited and current health of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
