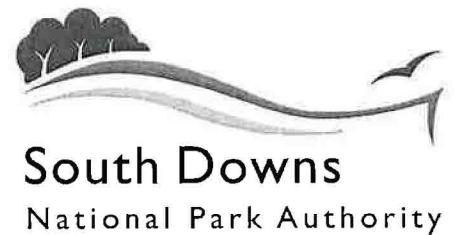

2. Two cherry trees. Removal of overhanging branches 25% - 30% reduction to fork stems
3. The Judas tree should have been attended under application to you Jan 2022, work now done
4. Walnut tree, at rear of property, a reduction of 30% in application will now be attended to.
5. Yew tree, Two low level overlapping branches which are creating will be removed as general tidying up at front wall level is overhanging the boundary. (Jan 22)
6. General tidying up of the laurel & bushes in centre, and holly bush.

8. Bay tree on hard standing area will be reduced
9. General attention to beach tree to ensure balance - removal of one side branch encroaching on the lawn.
