Oak (T1) in front garden of 21 Hammer Hill.

Due to proximity of the tree crown to the property and overhang of both the highway and neighbours' gardens, the following work is proposed:

- Crown reduction in height by 3.0m and lateral spread by 2.5m, all round, to finished crown dimensions of 17m in height by 15m in spread (all measurements approximate).
- Removal of ivy growth from the trunk to reduce weight and wind resistance

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
