Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

There is a large Holm Oak that grows up and Out from our boundary wall (photo1) and overhangs the seating area below (photo 2). Additionally, there is a large Copper Beech tree, that also overhangs the seating area (see photo 2). The holm oak needs to be lopped in height (photo 2) width, back to the telegraph pole, (photo 3 & 5) and depth (photo 4). The works are needed to be carried out, as the tree is very top heavy. Additionally, there is a risk to the flint wall collapsing if the tree comes down, for example in a storm. The holm oak is not subject to a TPO, and (successful applications) to SDNP have been made before in respect of works to this tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
