- T01. Norway Spruce Fell
- T02. Lawson Cypress Fell
- T03. Western Red Cedar Crown lift to 5m from ground level.
- T04. Western Red Cedar Crown lift to 5m from ground level.
- T07. Western Red Cedar Crown lift to 6m from ground level and prune back to offer a 3m clearance from the property.
- T09. Lawson Cypress Fell
- T10. Sycamore Fell

T01 has fruiting bodies present on the root plate and subsequently poses a risk of failure. T02 has historically windblown and leaning at a 45 degree angle with a poor canopy. T03/T04 are just to raise the low canopies. T07 is within close proximity to the property and causing damp issues. The aim of those works are to reduce the overhang to the property and clear adjacent power cables. T09 is of poor canopy and leaning into T02. T10 is close to the rear of the property and fully ivy clad with a poor canopy.

The owner wishes to mitigate the removal of each tree with replacement specimens with a better future to improve the landscape.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
