- T.1 Oak tree.
- Reduce the tree overall by approx 1/3, by the removal of approx 4m in height and 3m laterally, and crown thin by approx 20% by the removal of contested and crossing/rubbing branches also remove the ivy from the entire tree and any significant deadwood.
- T.2 Ivy covered ash tree,
- Dismantle the tree in sections to near ground level and stump grind.
- T.3 Whitebeam tree,
- Dismantle the tree in sections to near ground level and stump grind.
- T.4-T.5 Two yew trees,
- Hedge trim both yew trees overall to tidy.

Reasons for the proposed work;

- T.1 Maintain size of tree given its location.
- T.2 Sparse crown with signs of ash dieback, with dead limbs resulting from previous 'reduction work'
- T.3 Significant basal decay.
- T.4-T.5 Maintenance to retain size of trees.
