Identification of Tree(s) and Description of Works

Following an alleged breach of tree preservation order pursuant to planning permission DM/22/00285/RM and subsequent investigation the owner of Plot 5 in response submitted an arboricultural assessment compiled by All About Trees. In July 2023 the summary of proposed works were accepted in principle by Durham planning, ref on letter dated 18th July 2023 EN/23/00151.

As a result of visiting Plot 5 to provide a quotation for the work, I requested a site visit regarding further supplementary work, this site visit took place on Friday 23rd February, present was Simon Chivers, Christine Wood, myself and business partner.

The following supplementary work was agreed in principle:

T9 - Cherry - 3 metre crown uplift - remove one branch leaning at 45 degrees towards the dwelling back to first union. (No photo uploaded) T14 - Norway Maple - 3 metre crown uplift.

T16 - Norway Maple 3 metre crown uplift. The larger lower lateral is to be pruned back to its first union

The lower branches of T9, T14 &T16 are growing close to the dwelling on the side where the solar panels have been installed. The uplifts will reduce shading and create space between the trees and the dwelling.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
