Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Pine

To section fell to ground level due to damage being caused to two neighbouring driveways and the tarmac road of Westwood Avenue. The damage being caused to the driveway of Westacres is significant and worsening, despite remedial works, (as recommended after previous applications), being undertaken on numerous occasions. The undulations and raised brick sets in the driveway are now such that they present a serious trip hazard to the elderly couple who live there and anyone else using the driveway, unfortunately it is very hard to capture this in photographs. A quote has been sort for further remedial works to 17sqm of driveway, this is quite a considerable sum and the work would do nothing to stop the damage recurring. The damage has now reached the next driveway along, Malaga, with the owner having to lift brick sets and remove roots to maintain a level surface and the tarmac on Westwood Avenue, which is privately maintained, is being cracked and lifted

I fully appreciate the TPO in place on Westwood Avenue, it is a beautiful tree lined Avenue which should absolutely be preserved, it was one of the reasons we bought the house here 2 years ago. However, the pine tree on our property is causing damage which now could have serious safety implications for our neighbours and financial implications for us. I would be more than happy, if spacing allows, to plant a replacement tree at the front of our property with the existing cherry blossoms.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
