The proposed works are to reduce in height the leylandii hedge at the rear of the property by three meters to achieve a finished height of four meters. Also, to remove four of the leylandii that are apart of the same hedge that grow to the rear of the garage, reduce a white willow by up to two meters to create space from the adjacent garage and the leylandii hedge to the rear. the reason for the works is to allow more light into the property and open up the view from the rear garden. Also, to prevent the hedge and the willow from further growing onto the garage roof.
