T1 Oak, crown reduction by approximately 2m back to a suitable growth point, and remove lowest limb overhanging the drive /gate back to the main stem, and remove major deadwood.

T2 Oak closest to barn, crown reduction by approximately 1-1.5m back to suitable growth points and remove any major deadwood.

T3 Oak, crown reduction by approximately 1-1.5m back to suitable growth points and remove any major deadwood.
