| Please identify the tree(s) and provide a full and clear specification of the works you want to carry out |

- 1. Crown reduction to the roof line of the house at 139 Sandy Lane South of nine Sycamore tress bordering the properties of 139 and 141 Sandy Lane South
- 2. The work is required ahead of the installation of solar panels; currently the height of the trees is preventing c40% of available light from reaching the panels during the winter months and this will worsen over the summer period. The shadow cast by the height of the trees does not make it economically viable for the installation of solar panels. This has been confirmed through a Project Solar site visit
- 3. The work is supported by the owners of 141 Sandy Lane South
- 4. The tree heights are currently casting the entire garden and patio area into darkness and effecting the mental well being of the owners of 139 Sandy Lane South
- 5. 139 Sandy Lane South has a significant number of trees on site, none are requested to be felled and none will be added to the site
- 6. The trees are in a general conservation area and previous correspondence with Sutton Borough Council have confirmed there are no specific TPOs in place

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
