Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

1. Crown reduction to the roof line of the house at 139 Sandy Lane South of nine Sycamore trees bordering the properties of 139 and 141 Sandy Lane South
2. The work is required ahead of the installation of solar panels; currently the height of the trees is preventing c40% of available light from reaching the panels during the winter months and this will worsen over the summer period. The shadow cast by the height of the trees does not make it economically viable for the installation of solar panels. This has been confirmed through a Project Solar site visit
3. The work is supported by the owners of 141 Sandy Lane South
4. The tree heights are currently casting the entire garden and patio area into darkness and affecting the mental well being of the owners of 139 Sandy Lane South
5. 139 Sandy Lane South has a significant number of trees on site, none are requested to be felled and none will be added to the site
6. The trees are in a general conservation area and previous correspondence with Sutton Borough Council have confirmed there are no specific TPOs in place

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
