The scheme proposes the conversion of the existing building to provide ancillary accommodation for use by the adjacent dwellings. The ground floor of the building would be used to provide open plan communal studio/workshop space for use by the adjoining residents. In addition, a small W.C. and a plant room would be provided. The first floor of the building would contain a bat loft and a small mezzanine floor, with the rest being void space above the ground floor. To the Southern end of the Barn the Existing Bat Loft will be retained. In addition, the scheme proposes the construction of a new bat roost on dilapidated buildings to the West of the site.
