Tree works, limbing, dead wooding, felling, CAT scanning, stump grinding

3 x large ash require heavy weighted limbs overhanging car park to be removed. Dead wooding of multiple internal Maple trees in car park. 2 x Maples and 2 x self-set maples to be felled to ground due to very poor condition, stumps to be grinded to prevent trip hazard. Removal of dead wooding and limbs required due to high potential of falling on to public or vehicles causing damage or harm.

To reduce climbing working at heights. 3×1 x Large Ash Trees at rear right-hand side of car park require multiple heavy weighted limbs that are bending over the car park to be removed. Team to dead wood all internal maple trees within the car park area. Team to fell 2×1 poor health maple trees to ground, area to be CAT scanned prior to stump grinding. Team to create a 1m clearance around the exit sign, 2×1 Pine trees to be crowned up to 3m from ground. Trees to be cut to best horticultural practice
