**ICON TOWER INFRASTRUCTURE GROUP LIMITED:
PROPOSED DEVELOPMENT OF TELECOMMUNICATIONS BASE STATION AT LAND AT
HORNDEAN FOOTBALL CLUB, FIVE HEADS ROAD, HORNDEAN, PO8 9NU

We act on behalf of Icon Tower Infrastructure Group Limited (Icon Tower) – a code operator approved by Ofcom, to submit a Prior Notification Application for the proposed installation of telecommunications apparatus at the above location. This location has been identified as being necessary for specific technical and operational requirements.

The proposed development consists of:

The installation of a 25 metre high lattice tower supporting 12 no. antennas and 6 no. transmission dishes, the installation of 6 no. equipment cabinets, a 2.4 metre high palisade fence and ancillary development thereto - at land at Horndean Football Club, Five Heads Road, Horndean, PO8 9NU (NGR: 470018, 113535).

This proposed development is required to facilitate enhanced network coverage for the Mobile Network Operators in the area. This multi-user structure with secure compound and upgraded power supply will enable a consolidation of equipment and in time lead to the removal of unused infrastructure from the wider site and cell area.

The site selection and design are discussed further in the Site Supplementary Information document.

All Icon Tower installations are designed to be fully compliant with the public exposure guidelines established by the International Commission on Non-Ionizing Radiation Protection (ICNIRP). These guidelines have the support of UK Government, the European Union and they also have the formal backing of the World Health Organisation. A certificate of ICNIRP compliance is required for this installation and is included with the planning submission.
