Details of the pre-application advice received

With regards to pre-application advice being sought a meeting (as well as several emails prior to this) was held on the 16th May 2023 with Ruth Hardingham as well as Lauren Clarkson (who was assisting from a Conservation Area point of view). This meeting (and the email liaison prior to it) focussed on the general proposals (including solar panels on the roof which has been part of an alternative application). Highways, ecology and the general acceptance of cladding the building was discussed. It was indicated that recladding the façade of the building would be welcomed to improve the appearance of the building in the Conservation Area.
