T1 Scots Pine - Crown Reduction Works – Specification to include a sympathetic height and spread reduction of 2m, cutting back to strong secondary growth, to restore shape and balance, crown lift to 7m all round. Also to reduce the effect of defecating pigeons on patio area beneath tree. New shape indicated in red on image.
