The apple tree to be trimmed back is located within the boundary of an adjacent orchard, the whole orchard is owned by Mr Bradshaw of Rosebury House and is the subject of a TPO. It overhangs our drive. We wish to trim back branches as far as our boundary.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
