T1 - Watershoots to remove on silver birch 3 meter long hanging down over garden allow more light onto hedge and lawn

T2 - 3 very lowest branches to remove from beech, 3 meter long interfering with holly tree on roadside

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
