T1 - Lime tree situated in the rear garden, crown reduce in height by no more than 4.0m to alleviated the amount of weight on each of the muliple stems of the tree. The tree had a large stem break out and fall into one of the neighbouring garden. We climbed the tree to inspect the remaining stems and we recommend that a substantial amount of weight be taken off of each stem to reduce the risk of any other stems failing in the future. The stems are certainly fragile in their current state.

Please see the photograph that is attached to this application showing the proposed height.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
