The Beech tree is on the Southern edge of out boundary very near the driveway entrance. It is right next to the power lines and if it falls it will take out the power supply and block the lane. The tree office (Robin) came out around 1 to 2 years ago and explained that unfortunately, the tree is diseased and would need to be taken down. With the recent storms we have become more and more anxious and are very concerned about damage to our property and to our neighbours. We do not accept any liability for any of the damage the tree may cause if it falls. We contacted the national grid who originally were going to apply for the tree to be felled but after numerous discussions they decide not to help with the application or the cost of felling the diseased tree. I will attached the relevant photos which shows the disease to the tree.

The tree is the large Beech on the Southern boundary of our property by the power lines and the tree officer, Robin said we would need the tree to be felled.

If possible we would plant another Beech tree as long as it did not become diseased as well.
