1. THE PROPOSAL AND DESIGN & ACCESS

One of the existing 5no. cast iron projecting Garderobe support brackets has fallen away from the building. It is proposed to remove the top bracket clamps to all of the 5no. support brackets and replace with concealed splayed tie anchors and repair the fallen cast iron bracket and to reinstate it in its original position by dowelling and welding the existing broken integral cast iron spur to the bottom of the bracket and rebedding it onto the existing kneeler stone with brickwork around the tie anchors made good with lime mortar to match existing. As the work is only repair work there is no change to the existing design and access strategy.

2. CONTEXT

This statement is made in support of the application for LBC CONSENT Permission for the proposed repair works to the cast iron brackets supporting the projecting Garderobe above at Golden Hill Fort, Freshwater.

4. CONCLUSION

4.1 As these essential repair and replacement works propose to conceal the majority of the structural works within the mass solid brickwork external wall and then to re-lay the existing surface brickwork, removed to allow for the splayed anchors to be fitted within the external wall, and repointed with new lime mortar colour and texture matched to the existing lime mortar, we feel that this work will not have any visual affect on the listed facade and so should be fully supported by the LBC.
