It is proposed to remove the top bracket clamps to all of the 5no. support brackets and replace with concealed splayed tie anchors and repair the fallen cast iron bracket and to reinstate it in its original position by dowelling and welding the existing broken integral cast iron spur to the bottom of the bracket and re-bedding it onto the existing kneeler stone with brickwork around the tie anchors made good with lime mortar to match existing.
