Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Sycamore - Remove deadwood from the canopy limiting the wound and size to a maximum dimension of 50mm.

T2 - Sycamore - Lateral reduction on the west side of the lower canopy side by 1.5 - 2m or to the nearest growth point and limited the wound size to 75mm.

Reduce elongated limb growing towards property by 1 to 1.5m or to the nearest growth point and limit the wound size to 75mm.

T3 - Sycamore - Reduce limb growing towards property by 1.5 to 2m or to the nearest growth point and limited the wound size to 75mm.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
