The application is to fell the oak tree T1 as indicated on the attached Tree Plan. The tree is leaning and has an irregular shaped canopy. It therefore has low amenity value. It was reduced on its east side following a neighbour's tree works application (ref 2012/8250). Its remaining canopy used to be integrated into the canopy of the oak tree at the rear of 6 Turnoak Avenue (T10 on Tree Plan), but that tree was heavily pruned following approval ref 2021/8268, leaving the irregular shaped T1.

7. Identification Of Tree(s) And Description Of Works continued ...

As within a TPO zone the trees covered by the order were not originally identified. When application 1999/8340. was made in 1999 the then Tree Officer, Gordon Holmes, identified that of the trees within the application site only four (all oak trees) were covered by TPO 626/088/1967. (See letter 9th February 2000.) Two of those oak trees were felled following approval of that application and as required at the time a Parrotia Persica tree was planted as a replacement.

Whilst felling of oak tree T1 will leave only two other trees on the application site covered by TPO 626/0088/1967 (T2 Oak and T3 Parrotia) there are other trees within and close to the application site as indicated on the tree plan, so it will not be appropriate, I believe, to require a replacement tree to be planted.
