Sliver Birch (T1)

To be removed to ground level.

Has numerous brackets of Birch Polypore on both sides of the main stem. Large cavity within the main stem at just above breast height which runs up the stem, I can loose my arm within the cavity. A smaller cavity higher up at first union is causing water ingress into the larger cavity below. Birch has numerous failures within the crown within close proximity to 10 Mauntley Avenue which has left hangers and broken limbs with no suitable growth points. Poor shape due to failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
