Removal of horse chestnut tree located in north corner of the garden.

This tree is causing shading to the neighbours garden in the morning.

Also noted is that there is movement of the tree root plate during high winds.

This tree has had work done to it in the past to remove a side limb to reduce weight and also reduce shading of the neighbours garden.

If approval is granted for removal, the garden will be replanted with 2x fruit trees of a more appropriate size for the garden and surroundings

while providing habitat and pollen for bees and other fauna.
