- 1- This is a five bedroom detached house with a total GIA of 243.7 sqm part, which was built as a one dwelling house. According to the former owner the house was rented out to a doctor with his family, he used part of the house as his private medical clinic for private consultations exclusively for the polish community. -----
 - 2- The space of the house used for the clinic is a total of 30.7 sqm whereas the house is as mentioned above 243.7 sqm which makes it 12.6% of the total GIA of the house total space according to the former owner. -----
 - 3- The tenant closed down the clinic they had and had moved out of the house and the house has been vacant since beginning of 2023. ----
 - 4- We purchased the house in June 2023 and the house was completely stripped out and there was no clinic in it. When we purchased the house, the ground floor that was being used as clinic was completely stripped out and only some walls were left and it is all just a shell. -----
 - 5- The previous owner had applied to use part of the ground floor as a medical surgery and the rest of the property was being used as a dwelling house. -----
 - 6- We now wish to revert the property to the original use of the property which is a single dwelling house, so we can carry out some renovation work and move in to live at the property as we are a big family. -----
 - 7- As we are now the owners of this house and because our family has grown big, we have decided to move into the house and move our father to live with us after our mother had passed away, because we do not wish to send our father to a caring home, however, for this to be practical we need to revert the space that was being used as a clinic by the previous tenant to become again part of the our dwelling house, especially that our father is very old and cannot climb the stairs. -----
 - 8- We hope your understanding to our situation will result in a positive outcome and grant us the permission to change the use of that part of the house from D1 medical Clinic to residential use. -----
 - 9- The house is now a five-bedroom house with and if we revert the house into a single dwelling house it will make our house a six bedroom house which will then become big enough for our large family. -----
 - 10- According to the former owner the tenant who was using part of the house as a surgery moved out beginning of 2023, so one year ago and since then the property has been vacant. -----
