Tree Species: Canadian Maple Tree  Tree Position: The tree is positioned as in the plan and lies northeast of the property.  The tree currently overhangs the main house (barn) building and the adjacent shed. The height of the tree is approximately 40 feet.
Proposed work:  Reducing the size of two of the main branches to prevent future damage to the main roof structure of the house(barn) and the shed.  Two main trunk branches are to be reduced to 15 feet above ground level.  A third easterly branch would be left intact.
