One Holm Oak located adjacent to caravan number AZ9. We would like to reduce the crown by three meters, the main stem has areas of decay and creates concerns for the elderly residents.

One Holm oak adjacent to AZ10

Reduce the east facing lower lateral limb by two meters. This limbs is exposed and likely to fail without a reduction in weight.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
