| Application to cut back and remove dead wood from 3 large trees overhanging our boundary from neighbouring driveway at the bottom of our garden. This includes 2 sycamore's and 1 silver birch which have large dead branches which drop into our garden and gate access below. The trees are on the driveway owned by Newton Park Place, Southill, Chislehurst. |
