Requesting permission to remove 2 stems from Quince tree. The tree has multiple stems but 2 overhang the driveway and footpath - the fruit in Summer attracts wasps and makes the public footpath slippery when it falls and rots.

Some of the residents that use the footpath have asked the owner to do something about the tree.

Removing the stems will not effect the amenity value of the tree, nor will it cause any damage. We also seek permission to reduce 2 x Yew trees by 25%, to maintain the height and shape of the trees and encourage more growth at the sides to balance the trees.

Finally we would like to reduce the small Beech tree at the front of the property by 25% to maintain its manageable size.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
