The tree is an (one) Oak tree.

We would like to pollard the tree to remove all of the small branches. In addition we would also like to reduce the crown and cut back the main thickest trunks/branches by approximately 30-35%.

In doing this, we would hope that this would allow our cars to be parked on the driveway, and keep them off the road, in a position that kept them clean from bird excrement. It would also provide a clearer and longer gap between our tree and our neighbours guttering.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
