Identification of Tree(s) and Description of Works

We want to request permission to fell the cherry tree on our premises.

Tree description and reasons for work:

Cherry Tree 1 sits within the boundaries of the May Cottage, Grade II listed property. It is positioned in a side yard between two cottage walls, 4.2 meters away from the West-facing side and 2.8 meters away from the South-facing sides of the cottage. It is also about 3.5 meters away from the adjacent Grade II listed stone barn that belongs to the May House. The cherry tree is about 9 meters tall, diameter of the trunk before it splits into branches is 1 meter.

We have discovered the roots are growing beneath our house and into the walls, compromising the structure of our property. We found that roots were growing inside the cottage into the wall of our fireplace. We have recently discovered that its root system stretches towards the neighbouring May House stone barn, which is only about 3.5 meters from the tree.

As advised by the Association of British Insurers, a mature Cherry tree requires a 10-meter distance from the house to be considered safe; anything lesser may invalidate our house insurance in case of the foundation or drainage damage caused by the tree roots.

We propose the following works:

- Felling of tree

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
