The tree has some large crossing branches which have included bark which is affecting the integrity of the tree andin high winds causes some creaking. During high winds there is also significant movement of the crown, I would like to reduce this by about 20% to reduce the wind drag

This is a beautifull tree which is in need of remedial attention.

There is also a Field Maple 91/00613/C T3 which is too close to the Hornbeam, as such they are detrimental to each other, it might be prudent to remove it to benefit the Hornbeam.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
