Helen & Douglas House is a warm, homely place for local children living with life-limiting and terminal conditions, and their families. We provide round-the-clock care in a comforting environment. Our hospice is filled with laughter, whilst also being a peaceful place where families can create happy memories in their last days, weeks, months, or years together.

Helen House is the main Children's hospice care building for our charity. Location 37 Leopold Street, Oxford OX4 1QT.

To ensure constancy of care in the event of a power failure, a backup diesel generation is on site for the building. Fuel tank capacity of generator 200 ltr.

In order that fuel can be dispensed for the generator to top up the existing fuel tank a fuel store has been chosen.

Our primary location choice for the fuel store was not approved by our insurer due to the proximity to Helen House buildings. However, they have approved our secondary location in Douglas House Car Park, 14a Magdalen Road Oxford OX4 1RW.
