Thanks for your email. Our map seems to be working for me now – the farmhouse is showing as grade II listed. Our system shows that College Farm Court has been treated as curtilage listed since it was converted, and therefore the same still applies.

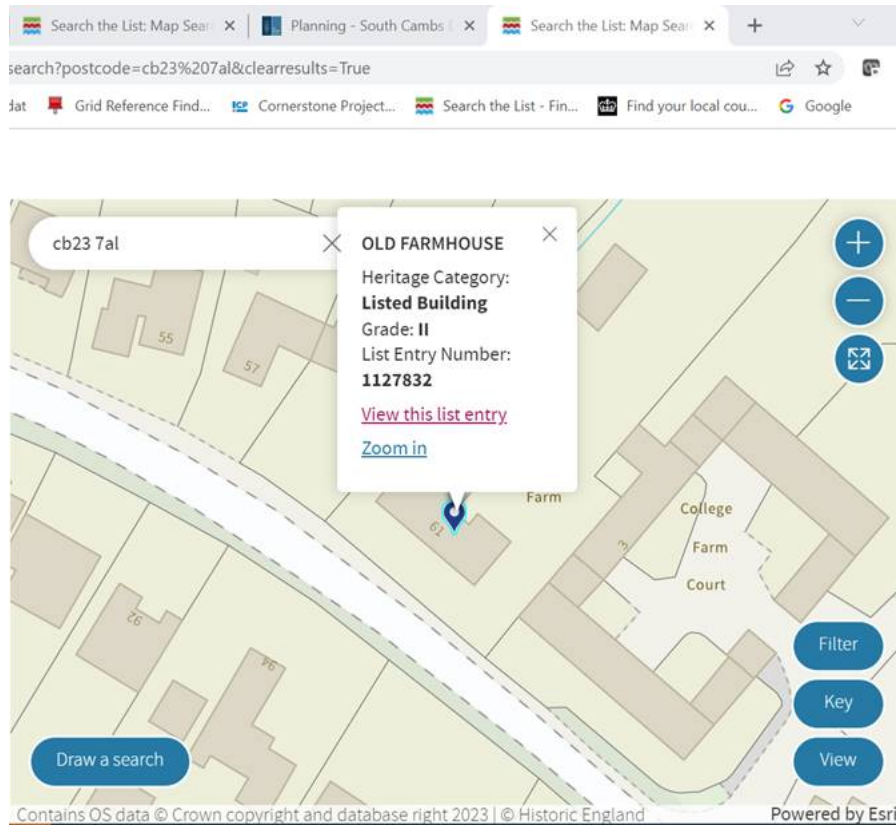

I am being asked to take a look at some repairs to the property at 1 College Farm court, Barton CB23 7AL but noting that the adjacent property is Grade II listed, I send this email to establish if this property is considered to be a curtilage structure of the old farm next door and/or locally listed with the council.

I have taken a look at the map on your website but it does not appear to be working, given that the adjacent property is not showing as listed despite it appearing on the English Heritage website and listed as being Grade II – list number 1127832.
