PRE-ORDER CONSULTATION - NETTLEWORTH MANOR, WARSOP PARISH, NOTTINGHAMSHIRE NG19 8LJ

The County Council is considering proposals for the exnguishment of two restricted by ways and a brideway in the above-menoned parish, and concurrent creation of a replacement brideway as shown on the a Gached plans.

The restricted byways were originally the subject of a claim to add the route to the Definive Narl p made by the Ramblers Associaon based on historical obcumentary evidence. The North ghans hire County Council (Var roop Restricted Byway Nos.61&62 and Bridleway No.63) Modificaon Order 2022 to add the restricted byways and a bridleway was made in February 2022, and has not yet been confirmed. The Creaon and Exercising is hneen to Order s are conngent on the North difticaon Order being confirmed.

The proposed Restricted Byway Warsop No.61 is in part covered with trees and is missing a crossing of the River Meden. In consequence the County Council have felt it is expedient that an alternave rout e is put in place and an exnguishment made, should the Definive Map Modil if ica on Order becomfirmed

The replacement bridleway would follow an amended route between B and E on the Creaon pl an, running along the field edges instead of through Ox Pasture Wood. Warsop Bridleway No.63 duplicates part of Restricted Byway No.62 and would be exerguished at the same ne.
