T1 - mixed Ivy covered hedgerow including semi mature cherry tree.

Reduce the hedge back to 1.8m removing the self seeded beech, sycamore saplings and Elderberry to ground level and treat stumps. Crown lift and sever ivy on the Cherry tree (T1) to clear pathway and neighbouring garden fence and wall. Leave one or 2 beech saplings at current height to create hedgerow trees along with the cherry. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
