# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Following the visit on 22 February 2024 by Martin Jenkins, NCH (Arb), Tech Cert (ArborA), TechArborA, the following works were discussed and agreed with the applicant to maintain the trees at a size suitable for a small domestic urban garden.

(1) Gleditsia in the back garden. Reduce all over by up to 3.0m to leave in a more compact size better suited for its location.

(2) Holly growing in front garden. This tree is showing poor vigour and growing very close to the boundary wall and house. Fell to near ground level.

(3) Ceanothus overhanging front pavement. Reduce all over by up to 2.0m to tidy and contain.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
