Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Located on land adjacent & Helios House land- W1 - Mixed spp. woodland of mostly Oak, Ash and Field Maple with bramble / scrub understorey - Remove (fell) Oak, Ash and Field Maples stems within 20.0m of the building to near ground level and remove any regrowth as it emerges [Herbicide translocation risk with watercourse (pond). Remove (fell) understorey scrub within 10.0m of the garage to near ground level and treat stumps to inhibit regrowth.

Located on land adjacent to Helios House - TG1 Mixed spp. group of mostly Bramble, Hawthorn and Blackthorn scrub. Remove (fell) all within 10.0m of the garage to near ground level and treat stumps to inhibit regrowth.

1. The tree works are proposed to stop the influence of the tree on the soil below the building foundation level and provide long term stability to Helios House, Clark Lane, NR34 8HN.

2. Estimated costs of repair to the building are a minimum of £180,000.00 if the influence of the tree remains and £16,644.40 if the proposed tree works are allowed to proceed. Getting permission will limit these costs. In the event of refusal we, or our clients, will seek to secure compensation for the additional costs incurred through Section 202(e)

3. Should the tree remian the total cost of repairs will be the superstructure repairs & alternative method of repairs (minimum) = \pounds 196,644.40 4. It is the expert opinion of both the case engineer and the arborist that the balance of probabilities the supporting information demonstrates the influence of the tree.

5. Note: further monitoring results may be submitted if these become available during the course of the application.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
