## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1, Ash . on front fence line boundary, Large specimen with Ash Die Back , remove to near ground level

T2, Poplar , adjacent to Nissan huts pollard back to a frame work just above the main knuckles to allow a managed tree to regrow and remove the risk of failure

T3 Poplar, adjacent to the Nissan huts , elongated limbs that are unbalanced and provide pulling weight which will eventually fail, pollard back to main knuckles to allow for regrowth that can be managed . Both T2 and 3 are very large trees that are unbalanced and not in the best of health.

T4, Sycamores by fire pit, dead remove to ground level on safety grounds.

T5, Willow adjacent to fire pit, low over gravel driveway, lift low canopy to 10 foot high to provide head room

A site visit is recommended and i will attend with the tree officer.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
