Whitebeam (T1) Crown lift to 3.5 metres and cut back to the boundary of the churchyard from neighbouring properties. This work is to allow more light to the neighbouring property.
Silver birch (T2) to reduce in height by 3.5 metres. The tree bends out at the top towards the neighbouring property. The reduction in height will mean the tree doesn't overhang the neighbouring property as much.
