Four Lime Trees alongside the driveway leading from Westgate to the North door of the church are managed on a three yearly basis where each year one third of the crown is cut back to the top of the main stem. This continually rejuvenates the trees and prevents them from becoming too large to manage. Also no branches are more than three years old and so less likely to fall as they are over a public driveway and also overhang the Holy Trinity School playground.

A smaller Rowan tree is leaning into the hedge and overhanging the playground. We will ask our arborist to greatly reduce the crown to render it safe from toppling, and if necessary we may ask for him to clear fell this tree and we will replant a new one in a more suitable area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
