Dear Tom,

Thank you for consulting the Forestry Group on application 24/0104/TPO - Remove Deadwood to T4 Common Oak), Fell T5 (Sycamore) & Fell T10 (Elm).

The application relates to essential safety works to mature trees which run around the edge of the housing estate. The works to remove deadwood from T4 are exempt and would be considered routine good management of the tree stock. T5 is a mature sycamore in poor condition with dead/necrotic bark and visual pockets of decay. The position of this tree next to Cambridge Road provides increased concerns over potential failure; the proposed felling to retain a 5m stump for habitat is reasonable. T10 is a dead elm which I am in agreement to fell.

There is no requirement for replanting as these works are within a woodland/shelterbelt.
