Amendments Summary

Please find below our response to the invalidation letter received on February 15th.

APPLICATION FORM

- The application forms have been corrected to now show the 'Other - Agricultural' use class.

PLANNING STATEMENT

- There was some confusion in relation to the maximum height of the agricultural building – we can confirm that the maximum height of the building will measure 7.5m and the elevations and planning statement have both/all been amended to reflect this. Please find attached a revised Planning Statement with this point amended.

PROPOSED FLOOR PLAN

- Floor plans have now been provided in line with the Council's validation requirements and can be found attached.

PROPOSED SITE PLAN

The following amends have been made in response to the invalidation letter:

- Annotations have been made to clarify which proposed buildings are subject to this application, which are to be subject to a future application & which have been approved via 23/03386/AGNOT
- Proposed surface water details are now shown on the plan along with any proposed areas of hardstanding
- It has been verified that the red line now corresponds with the other submitted plans

LOCATION PLAN

The following amends have been made in response to the invalidation letter:

- The error exporting to pdf has been corrected and the drawing is now confirmed to be saved/exported at 1:2500 scale
- The red line has been corrected to correspond to the proposed site plan and other plans and to correspond to the site area on the application forms (0.96ha.)

Additionally:

- It is confirmed that no works to create or alter the access to the proposed building or the access road to the building are required as part of this application because it simply relates to a proposed general-purpose/workshop building. Accordingly, it is considered that the red line does not need to be extended to allow for any such works.
- Separately, as requested, a Google Earth extract can be found attached demonstrating the location of the site in relation to Market Weighton (which is found to the east of the Site)

TRANSPORT ASSESSMENT/STATEMENT

- Given that the proposed development consists of general-purpose/workshop building, it is considered that the transport implications will be negligible as no regular/daily freight or HGV movements are to be generated from this application.

Given the above, we trust that everything that we have now provided is sufficient for a swift validation of the application and we welcome your confirmation that this is the case.
