Description of intended work:
Shortening lateral branches on north west quadrant by approx.2.2 metres to reduce intrusion and prevent encroachment with the adjacent dwelling No. 6 Great Gardens(Gaol Lane) therefore established a template as threshold pruning points for future cyclical maintenance to preserve established buffer zone of clearance between the tree and neighbour's property.
