Mr Dennis Swift Statutory Declaration:

I, Dennis Swift of Slodbrook Farm, Rode, BA11 6QQ do solemnly and sincerely declare as follows:-

1. My late father Mr Edwin Swift purchased the land (marked with an X on the attached 'Plan 1') and moved into a mobile home at Slodbrook Farm in 1975. He then lived on the land continuously until 2006. In 1992 he purchased an old school classroom from Davis Demolition which he converted to be habitable. He then moved into this unit and resided in it until 2006 when he moved to a sheltered accommodation in Beckington.
2. From 1990 I lived with my father at Slodbrook Farm 3 to 4 times a week and moved in full time in 2006 when my father moved to sheltered accommodation. Since 2006 I have continually lived at Slodbrook farm as my only residence.
3. In November 2017 construction works to build the new house (in the same location as the classroom) began, with it being completed in July 2018. During its construction I bought a caravan onto the site to live in. An extension to the new build was begun in June 2019 and was completed in September 2019.
4. The land at Slodbrook Farm has been continuously occupied for residential purposes since 1975 and I myself have permanently lived here from 2006 to the present day.

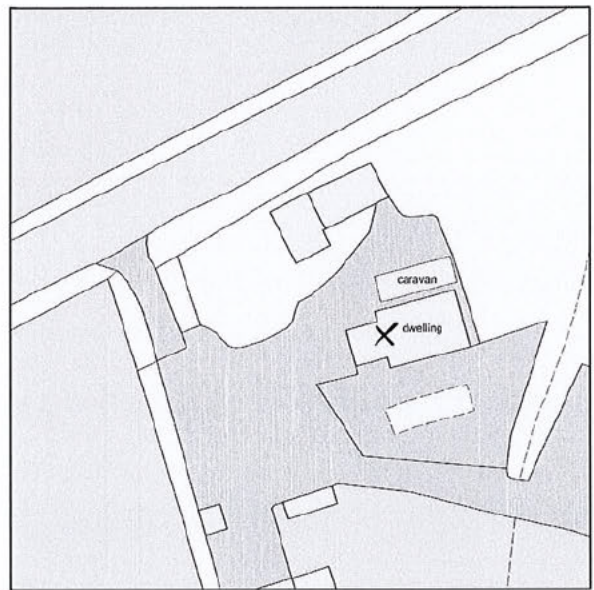
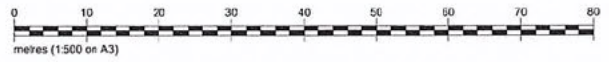

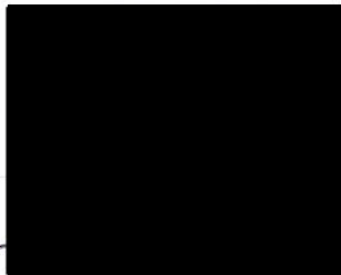

Ms Kim Maundrill Statutory Declaration:

I, Kim Maundrill of [REDACTED] do solemnly and sincerely declare as follows:-

1. I was in a relationship with Mr Dennis Swift's from 1997-2008. During this time, we lived separately with Dennis living with his father Mr Edwin Swift at Slodbrook farm (marked with an X on the attached 'Plan 1') 3 to 4 times a week until 2006 when he moved into Slodbrook full time. It is my understanding from Dennis that this living arrangement had been in place since 1990 prior to me knowing him.
2. As we didn't live together, I would visit Dennis at Slodbrook farm and he would occasionally stay with me on ad-hoc basis. During this time; I saw first-hand how Dennis and his father Mr Edwin Swift lived in and used the property known as Slodbrook farm for residential purposes, as their only home.
3. In 2001 we had a child (Miss Chantelle Swift) together. When Chantelle was a child I would take her to visit and stay with her father at weekends from Friday-Sunday. I would drop her off and pick her up from the property and have seen that the property has consistently been in use as a residential property throughout this time.

Mr David Fuller Statutory Declaration:

And I make this solemn declaration conscientiously believing the same to be true and by virtue of the provisions of the statutory declaration Act 1835.

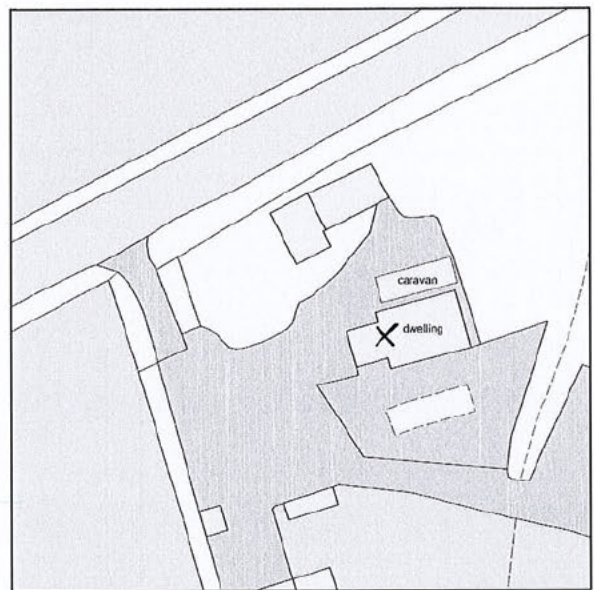
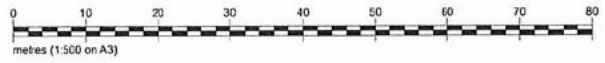
